Fastrack ARS (Audit Response System) integrates with the Fastrack Enterprise System and works best with Fastrack's Document Storage Module. Providers simply enter the audit number received from CMS and select the documents that they wish to electronically send to CMS in support of their response. Documents can easily be gathered from the Document Storage Module, the file server or any user's workstation and can include faxed, emailed or scanned documents. Fastrack maintains a list of all the documents/attachments transmitted as well as the status received back from CMS which includes acknowledgement of receipt of the electronic file by Medicare. All transmissions are secure and HIPAA Compliant and an unlimited number of pages can be submitted per audit. The system requires minimal training to implement and use.

Fastrack cites a number of benefits to the electronic transmission of supporting documentation over the traditional photocopying and mailing method:

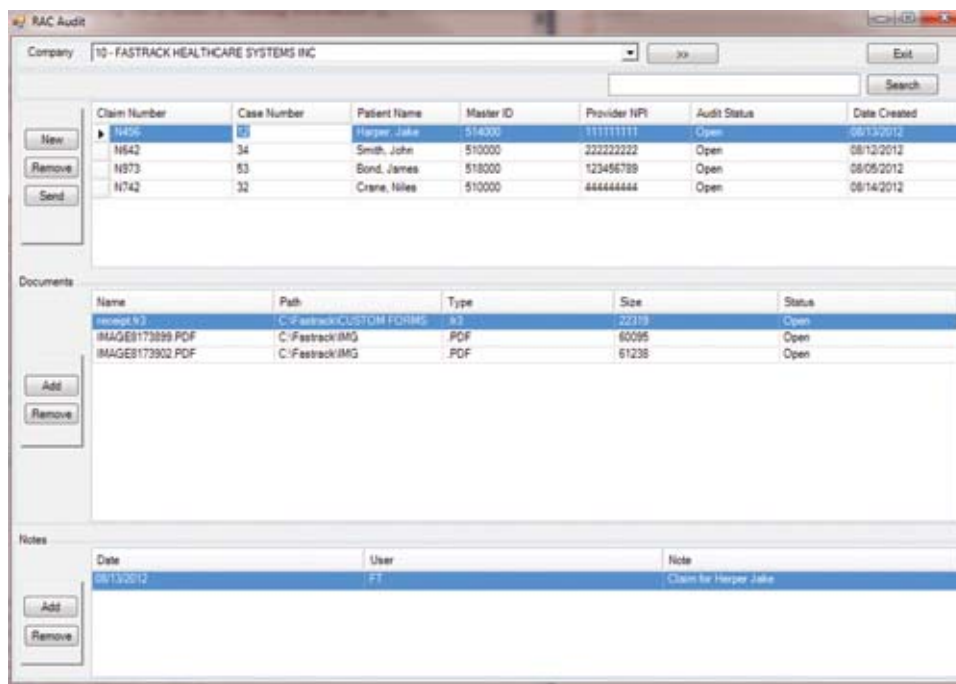
- Increased productivity including less time to respond to an audit reducing employee costs.
