Fastrack Releases Version 2012 - Over 100 New Features Supports Multiple Monitors Per User

A key new feature designed to improve provider productivity is the ability to have an unlimited number of windows opened at the same time along with the use of multiple monitors. According to Spencer Kay, President/CEO of Fastrack, "With Version 2012, our clients can have multiple patients, orders, products, and more, opened at the same time, benefiting from the ease and speed of moving back and forth between screens. A key benefit is that when a patient, referral source or physician is on the phone, customer service can quickly respond to inquiries. Having multi-monitors per user on the system, a feature not available from most other software vendors, makes this process even more efficient. A major productivity gain comes from being able to bring up a new referral form retrieved from the Fastrack Document Storage or received in by fax, displaying it on one monitor so that the user can easily refer to it when entering new patient data while accessing a second monitor."
